The Control units are a multi-port serial device that allows for the modems to be physically separated from the communications workstations. These devices, while reasonably robust in practice, do fail from time to time. Currently these devices are not covered by any support persons within Eskom, either within the IT or the OT environments.

In order to provide continued operation and to bridge the gap between the time of failure and the time for repair, the vendor must keep two operational devices in hand to cater for two failures at any point in time. This cost should be covered as part of the fixed costs of this contract.

The supply, configuration, installation and replacement of these units should be covered as part of the fixed costs within this contract.

In order to provide continued operation and to bridge the gap between the time of failure and the time for repair, the vendor must keep two operational devices in hand to cater for two failures at any point in time.

The router must be 3G, 4G, and LTE/LTI capable.

Communications Modems

The communications modems have for many years been purchased and managed at an OT level. The support covered here is the assistance to users in resolving communications errors on these devices. Different manufactures and models have differing functionality. This can lead to requiring different setups or configurations for different modems and meter combinations.

While no spares can be kept for the modems (there are too many different manufacturers in use), support should be provided in resolving issues related to the use of these devices. Similar to the Control units, the use of these devices will diminish over time, as field devices are moved to IP based communications.
