- 1.3. 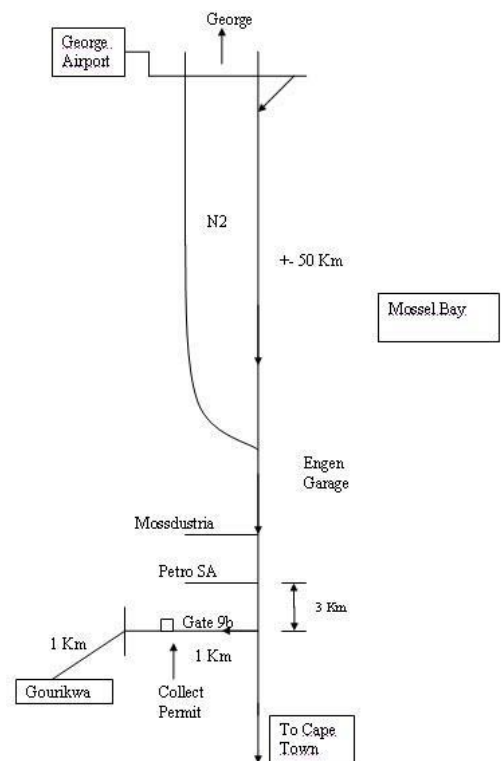
