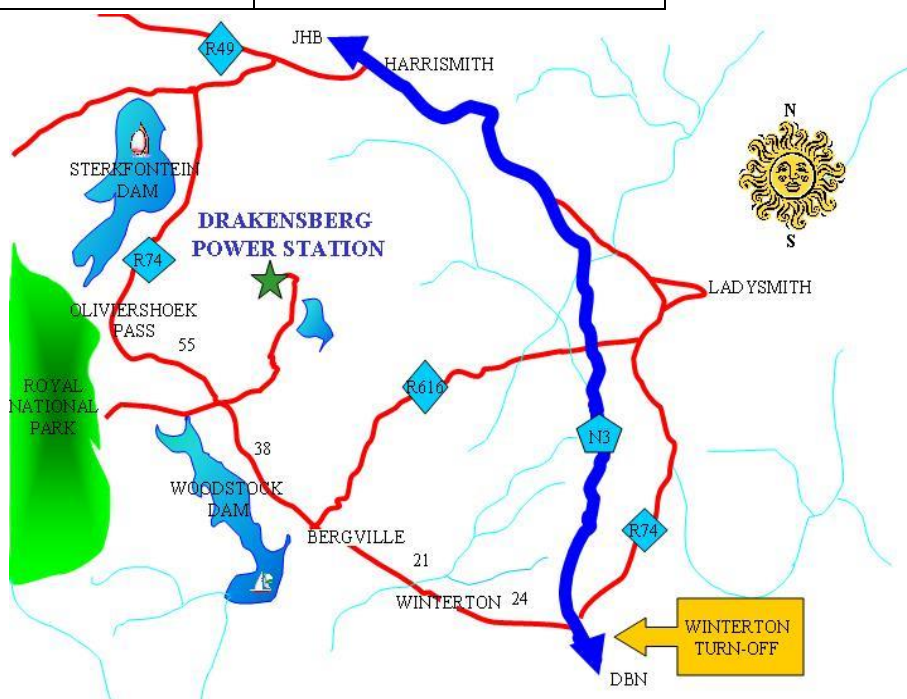

Off R74 between Bergville and Harrismith

is reached from Harrismith via the R49 to Kestel. The R74 turn-off to Bergville is 2,8 kms along the R49. Turn left after 8,7 kms and travel 23,5 kms to the Natal/Free State boundary at the top of the Oliviershoek Pass. From there, travel 13,1 kms down the pass and turn left. Follow the signposted directions to the power station for approximately 9,5 Kms. The total distance from Harrismith is approximately 60 kms

**SITE ACCESS REQUIREMENTS**

- Peaking Power Stations are National Key Points.
- The premises may be entered from 08:00 to 16:00 Mon-Thu, excluding public Holidays and from 08:00 to 12:00 on Fridays
- ESKOM does not permit any passengers to be transported at the back of any Truck, light domestic vehicle or enclosed light commercial vehicle.**
- Each person shall sign the site entrance Register if requested by Security
- Parking is allowed in the demarcated areas only and should it be required to drive on site, then please adhere to the following: Maximum speed is 20km/h; Driving is only allowed on tarred surfaces; Obey all road signs
