Purchase, Collect and Remove scrap contaminated mixed oils at Koeberg Power station, Melkbosstrand.

The purchaser must assure the site be left clean at completion of their collection and removal of the contaminated oil.

The scope of work will include the purchase, collect and removal of contaminated mixed oils at Koeberg Power Station, Melkbosstrand. Buyers must show their interest to participate by submitting all tender returnable specified on the tender enquiry.

The purchaser will be responsible for the safe collection, handling, removal, and transportation of the scrap oils.

It remains the responsibility of the buyer to be fully familiar with the condition of the scrap mixed contaminated mixed oils before tendering. Disputes regarding the condition of the items after tender closing will not be accepted or allowed.

The purchaser will be responsible for the safe collection, handling, removal, and transportation of the used contaminated mixed oils as well as to clean the site, qualified labour and suitable certified plant, machinery, equipment and transport for this purpose.

Payment shall be made to Eskom no later than five days after the date of the sale. The release of the scrap contaminated mixed oils to the new buyer will take place at tender award and payment to Eskom once quantities have been verified within 5 days of collection.

The goods on sale will be identified by Eskom.


